

Privacy Policy for Information Collected in Connection with the Registration to Receive Updates to the Jacobs Levy Rank Program

This Privacy Policy explains how we collect, use, and protect the personal information you provide when registering to receive updates and correspondence related to the Jacobs Levy Rank Program (the “Rank Program”). By registering, you agree to the terms of this Privacy Policy.

1. Information We Collect and How We Use Your Information

In connection with your request to receive updates and correspondence related to the Rank Program, we ask that you provide your name, email address, and location (country). We use this information to communicate with you regarding updates, support, or related information.

We do not sell your personal information to third parties and do not use it for marketing purposes.

2. Sharing of Information

The information you provide may be shared with trusted third-party vendors (e.g., cloud hosting, email platforms) who help us operate our Company’s website or the Company’s advisors. We may also share your information with legal or regulatory authorities if required to comply with laws, regulations, or legal processes or in connection with a business transaction, such as a financing, sale, merger, or other type of acquisition.

3. Data Security and Retention

We implement reasonable administrative and technical safeguards to protect your information from unauthorized access, disclosure, or misuse. However, no system is completely secure, and we cannot guarantee absolute security, nor are we responsible for any loss of such information or resulting consequences. We retain personal information indefinitely to fulfill the purposes outlined above or as required by law.

Some browsers offer a “Do Not Track” (DNT) setting to let websites know you don’t want your activity tracked. Because there is no standard on how websites should respond, our site does not take action based on these signals.

4. Location-Specific Rights

If you live in California, Colorado, Virginia, Connecticut, or Utah, you have extra privacy rights. Depending on where you live, these may include the right to (i) know what personal information we collect, why we use it, and who we share it with; (ii) request the information described in (i) from the Company; (iii) request access to or a copy of your personal information; (iv) ask us to correct or delete your personal information; (iv) opt out of the sale of your information or its use for targeted advertising (we do not sell your personal information or use it for targeted advertising); and (v) not be treated differently for exercising these rights.

To exercise your rights, please contact us at the email shown below in “5. Contact.” We will verify your identity if necessary and respond within the time required by law (generally 45 days, with an extension if needed).

If you live in the European Union, United Kingdom, or Switzerland, you have special privacy rights and can raise any concerns with your local privacy authority. We only use your information when you give us permission, when we need it to provide you with the file or service you requested, or when it helps us run and improve our website. In addition to the opt out above, you can ask us to see, fix, or delete your information. Because our company is in the United States, your information may be stored here.
